Clinic will be taught by Mary Jo Miller, owner, trainer, and judge of both llamas and alpacas. Mary Jo has experience not only raising camelids, but has also trained several National Champion animals, both llamas and alpacas. Mary Jo has participated as an instructor for ILR-SD Fleece, Halter and Performance judging seminars/clinics.

#### **Day One (Basic Training) topics will include but not limited to:**

Raising and training from cria to adult.  
Ground work for young animals  
Training animals that are purchased a bit older

Halter training, doing shots, loading into the trailer, catching your animal

#### **Day Two (Performance Training) Topics will include:**

Where to start!  
Desensitizing  
Expectation of the obstacles -how are they judged  
ramps, water, backing, and the fingers of death- Oh My!!

**Questions are encouraged!! This is a hands on interactive clinic. Come ready to participate!**

A **limited number** of participant's animals may be hauled in for this clinic. **Please make arrangements prior to coming.** You will need to stall your animals in your trailer or in your

own panels. There is no extra housing at our farm 😊

**Out of state animals** are required to have an 840 microchip and a health certificate within 30 days to comply with Michigan law. I have a chip reader on the premise.

**In state llamas born after March of 2012 also must have an 840 microchip.** Animals born prior to March of 2012 do not need a microchip. This again is to comply with Michigan law.
